- Improving intellectual property laws, regulations and rules;
- Reform and improve major policies on intellectual property rights;
- Improving intellectual property rules in emerging fields and specific fields;
- Strengthen the judicial protection of intellectual property rights;

- Improving the pattern of collaborative protection of intellectual property rights;
- Improving the quality of intellectual property creation;
- Strengthen the comprehensive use of intellectual property rights;

Some highlights of the Outline include:

- Promote the completion of the revision of the "Regulations for the Implementation of the Patent Law of the People's Republic of China", and promote the revision of the "Trademark Law of the People's Republic of China" and the "Regulations for the Implementation of the Trademark Law of the People's Republic of China".
- Promoting the revision of the Regulations on the Implementation of the Copyright Law of the People's Republic of China, the Regulations on the Collective Administration of Copyrights, the Measures for the Implementation of Copyright Administrative Penalties, the Trial Measures for the Voluntary Registration of Works, and the Measures for the Registration of Computer Software Copyrights.
- Promote the formulation and revision of the Anti-Unfair Competition Law of the People's Republic of China and related supporting regulations. Promoting the revision of the intellectual property clauses in the Electronic Commerce Law of the People's Republic of China. Promoting the revision of the "Regulations on the Protection of Commercial Secrets" and "Provisions on Prohibiting Abuse of Intellectual Property Rights to Exclude and Restrict Competition".
- Promoting the revision of the Measures for the Protection of Intellectual Property Rights at Exhibitions.
- Obvious examination of design and utility models.
- Promoting the revision of "Several Provisions on Regulating Patent Application Behavior".
- Continue to optimize the network layout of overseas intellectual property dispute response guidance centers, and select the third batch of overseas intellectual property dispute response guidance local sub-centers.
- Carry out in-depth special "blue sky" rectification actions in the intellectual property agency industry. Accelerate the improvement of the intellectual property service industry supervision system, improve the long-term mechanism for the supervision of the agency industry, and promote the implementation of credit evaluation management.
- Actively promote the process of joining the Comprehensive and Progressive Agreement for Trans-Pacific Partnership (CPTPP).
