# FY 17 Omnibus Vote Expected on Thursday; Hearings on FY 18 Move Forward Despite Lack of Budget Resolution

#### **Legislative Activity**

On April 29th, an agreement for a fiscal year 2017 Omnibus bill had been reached. Although the text was not available at the time of posting, it is expected to be released in short order. Last week, as anticipated, a Continuing Resolution (CR) was enacted to allow for additional time to iron out the final details of the FY 17 omnibus measure. Negotiations for that legislation progressed more quickly after President Trump dropped his insistence on funding for a border wall and denial of funding for health insurance subsidies. Controversial policy provisions on which Republicans and Democrats were debating include but are not limited to- funding for Planned Parenthood; financial aid for Puerto Rico; the Department of Labor's fiduciary rule; and health benefits for coal miners.

Last week, House Minority Whip Steny Hoyer (D-MD) stated that House Speaker Paul Ryan (R-WI) has said that a vote would be scheduled for Thursday. This would allow the customary full 72-hours to review the text of the bill. Once the House clears the measure, Senate Majority Leader Mitch McConnell (R-KY) has said that his chamber would take up the bill immediately. House and Senate leadership from both parties have not suggested that another CR would be needed.

In addition, despite the lack of a budget resolution, work on FY 18 has begun in earnest, with several hearings scheduled this week in the House and Senate Committees on Appropriations.
